





3) NAME AND ADDRESS OF TRUST:



4) MAIN OBJECTS OF THE TRUST -

(a) EDUCATIONAL:

- (i) To establish, maintain, run, develop, improve, extend, grant, donate for and to aid in the establishment, maintenance, improvement and extension of schools, colleges, polytechnics and other educational institutions including vocational training centers, research centers and audio-visual educational centers and hostels for students pursuing their studies.
- (ii) To give donations to educational institutions.
- (iii) To constitute Scholarships to poor and deserving students to enable them to continue their studies and to give grants for fees and other charges or re-imbusement for costs of books, instruments and other educational aids for their educational purpose.



- (iv) To help establishments of student's hostel and to give other assistances for poor and deserving students to find in-expensive living accommodation to enable them to prosecute their studies.
- (v) To give loans at nil or subsidized rate of interest to students to enable them to prosecute higher studies.
- (vi) To do all that is necessary and incidental to the purpose of achieving the objects in (i) to (v) above and any other activities to promote education of adults as well as children.

**B. SPORTS AND GAMES:**

- (i) To establish, maintain, develop, run, improve, extend, grant, and donate for and to aid in the establishment, maintenance, running, development, improvement and extension of playgrounds, stadium facilities for games and sports both indoors and outdoors, gymnasia and other required facilities for physical training and fitness free of cost.
- (ii) To sponsor, organize, run and assist in the organizing and running of various sports, tournaments, competitions, seminars on sports and related subjects to coaching campus and training programs.
- (iii) To sponsor and provide grant, medals, prizes etc., to deserving sportsman/sportswomen for specialized training, coaching and for participating in various tournaments or competitions.
- (iv) To promote sports and games in general.
- (v) To do all that is necessary to and incidental to the purpose of objects (i) to (iv) above.

**C. MEDICAL RELIEF:-**

- (i) To establish, maintain, run, develop, improve, extend, grant, donate for and to aid in the establishment, maintenance, running, development, improvement and extension of hospitals, clinics, dispensaries, medical laboratories, research units with special emphasis on medical including Indian systems of medicine like Ayurveda and similar institutions affording treatment, cure, rest recuperation and other medical relief to the public

including relief to the aged, the physically handicapped and the mentally retarded free of cost. These institutions will be run on charitable lines.

- (ii) To establish, maintain, develop and donate for the establishment, maintenance and development of blood banks free of cost.
- (iii) To organize, run and assist in the organizing and running of free medical camps.
- (iv) To provide housing, food, clothing and medical care for the aged free of cost.
- (v) To do all that is necessary and incidental for the purpose of achieving the objects. (i) to (iv) above.

**D. RELIEF TO THE POOR AND NEEDY:-**

- (i) To assist and provide for the poor and needy by constructing community halls, rest houses, orphanages, old age homes etc., to conduct feeding of the poor and to give food, clothing and cash grants to the poor, and to grant donations for the support of the inmates of the orphanages, old age homes, rescue and rehabilitation centers and similar institutions. The poor may also be assisted by way of teaching of crafts, engineering, technical and similar skills and industrial training including on the job training etc.,
- (ii) To provide relief by giving cash grants in times of natural calamities like earthquakes, floods, famines etc.,
- (iii) To provide cash grants to the poor in times of death in their family.
- (iv) To do all that is necessary and incidental for the purpose of achieving the objects in (i) to (iii) above. Provided that in the advancement or achievement of any of these objects no business will be carried on.
- (v) To give assistance by way of financial or by kind through distribution of books, notebooks, cloths, uniforms, meals etc., for the poor and indigent.

**E. OTHER OBJECTS OF GENERAL UTILITY:-**

- (i) To establish, run and aid free public reading rooms, libraries.
- (ii) To promote by all means, eradication of social evils, such as dowry, child marriage, unsociability, drinking, smoking, drug abuse etc.,
- (iii) To establish, run and aid meditation lecture halls to which all sections of the public will have access.
- (iv) To carry out awareness, programmes relating to aids and other diseases.
- (v) To start, establish and to run hostels for students of the Institutions run by the Trust and if possible it may accommodate other students.
- (vi) To render help and assistance to other Institutions which are engaged in the activities of similar nature.
- (vii) To undertake and to do any other work of similar nature aforesaid and to carry out any other work to promote the aforesaid objects.

**(viii) BENEFICIARY CLAUSE :**

For the sake of clarity it is hereby stated that all the above objectives shall be carried out for the benefit of the public at large, irrespective of the caste, creed, religion and sex. —

**(ix) UTILISATION CLAUSE :**


The funds and the income of the Trust shall be solely utilized for achievement of the object of the Trust and no payment shall be made to the Trustee by way of profit, interest/dividends etc., —

**5. TERMS OF TRUSTEESHIP: -**

The aforesaid TRUSTEES shall be TRUSTEES for life unless removed. Any person, who is major, is of sound mind and solvent is entitled to become a trustee, provided the concerned person is co-opted by the Managing Trustee or in his absence by a two-third majority decision of the TRUSTEES.

6. The number of the TRUSTEES shall not be less than 3 (Three) and shall not exceed 7 (Seven). The remaining 2 (Two) TRUSTEES may be appointed by the First TRUSTEES by nomination. Each of the TRUSTEE'S is empowered to nominate his/her successor who is acceptable for the other TRUSTEES who shall hold office for

such councils committees etc. shall hold office for such periods as may be determined by the Board of TRUSTEES.

#### 9. POWERS OF THE TRUSTEES:-

Without prejudice to the generality of the powers, the Managing Trustee and in the absence of Managing Trustee in the place of activities on his express authorization in writing the other TRUSTEES shall have the following powers:

- (i) To employ or terminate clerks and other employees, agents, bankers, accountants and others on such remuneration as they may think fit. To appoint advocates, attorneys and to execute powers of attorney etc., for and on behalf of the trust.
- (ii) To delegate the powers as they can lawfully delegate to any person and to execute such instruments as they may think fit for the purpose.
- (iii) To convert, to call-in, to ~~sell~~ or otherwise dispose of any of the investments comprised in the trust property and to re-invest or change the nature of any other investment contained therein.
- (iv) To compound and settle any claims against the trust.
- (v) To invest the funds of the trust in such manner as permissible under section 11(5), read with section 13 of the Income-tax Act, 1961, as may be amended from time to time, so as to ensure exemption from taxation.
- (vi) To withdraw any power or revoke any appointment of any employee or attorney.
- (vii) To open and operate Bank Account/s with any Bank/s by passing a resolution as to where to open the Bank account and who should operate the same.
- (viii) ~~to purchase any immovable and other properties for the trust. To pull down, renovate, alter or to add to any of the immovable property of the trust.~~ To purchase any immovable and other properties for the trust. To pull down, renovate, alter or to add to any of the immovable property of the trust.
- (ix) To let any portion of any immovable property forming part of trust found at such rent and for such period and on such terms and conditions as they may think fit and accept surrender of any lease.





- (x) The TRUSTEES shall have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the Trust Estate and/or the Trust Properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and/or the Trust Properties and to do all other acts and things fully and effectually without being liable or answerable for any bonafide loss occasioned thereby.
- (xi) All Proceedings and questions and matters arising at the meeting of the Trustees shall be decided by a majority of votes and in case of equality of votes, the Chairman shall have a casting vote PROVIDED HOWEVER that notwithstanding anything herein stated no question dealing with the disposal of the corpus of any of the Trust Properties and/or investment out of the Trust corpus shall be decided except with the consent of the Chairman of the Trust.
- (xii) In case of difference of opinion between the Trustees, the opinion of the majority shall prevail and if the Trustees are equally divided in any matter, the Managing Trustee shall have a casting vote.
- (xiii) A resolution in writing circulated amongst all the Trustees and signed by a majority of the Trustees shall be as valid and effectual as if it has been passed at a meeting of the Trustees duly called and convened.
- (xiv) Notice of the meeting of the Trustees and all communications may be sent to the Trustees at their addresses registered for the time being in the records of the Trust.
- (xv) All meetings of the Trust shall be held at such place and at such time as the Chairmān of the Trust shall decide from time to time.
- (xvi) A Trustee who is unable to be present at a meeting of the Trustees, may send his/her views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.

No amendments shall be carried out, without the prior approval of the Commissioner of Income-tax Act.

**REIMBURSEMENT CLAUSE :**

15. The TRUSTEES for the time being of these presents shall be entitled to reimburse themselves and pay discharge out of the trust fund all expenses incurred in or about execution of the trust and powers of this presents. The TRUSTEES are not entitled for any remuneration for services rendered but shall be reimbursed for any expenses that they may have incurred in the discharge of the duties/powers.

**AMENDMENT CLAUSE :**

16. No amendments to the Trust Deed shall be made which may prove repugnant to the provisions of Section 2 (15), 11, 12, 13, and 80 G of the Income Tax Act, 1961 as amended from time to time. Further, no amendments shall be carried out without the prior approval of the Commissioner of Income Tax.

**DISSOLUTION CLAUSE :**

17. In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the TRUSTEES, but the same shall be transferred to another charitable Trust / Society, whose objects are similar to those of this Trust and which enjoys recognition Under Section 80 G of the Income Tax Act, 1961 as amended from time to time.

**IRREVOCABLE CLAUSE :**

18. The Trust formed by these presents is irrevocable.  
19. There is no immovable properties in the Name of the Trust as on date.
